



## Treasury Department Releases Explanations of Biden's Tax Proposals

On May 28th the U.S. Treasury Department releases its explanations of the Biden Administration's tax proposals ("Green Book"). Below is a link to the full document.

## **Significant Proposed Changes:**

- Capital gains & dividend rate: proposed 43.6% for taxpayers with an adjusted gross income of over \$1M including ACA taxes are likely to retroactively go into effect the end of April, 2021.
- *Gift & death tax:* Triggers immediate taxable income, effective date for gifts or individuals dying after 12/21/2021.
- Corporate tax rate: 28% beginning after 2021.
- Repeal of 1031 tax-free exchanges: will go into effect for exchanges completed after 12/31/2021.
- *Individual rate*: 39.6% beginning after 12/31/2021.
- Carried Interest rate: taxed as ordinary income beginning after 12/31/21.
