

Relationship Summary

Premier Wealth Advisors LLC is registered with the Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services and fees differ, and it is important for you to understand the differences. Free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://investor.gov/CRS), which also provides educational materials about broker-dealers, investment advisers, and investing.

What investment services and advice can you provide me?

We offer investment advisory services to retail investors, which principally include wealth management and financial planning. When providing non-discretionary advisory services, you make the ultimate decision regarding the purchase or sale of investments. We only offer advice with respect to certain types of investments, which generally include mutual funds and exchange traded funds through the utilization of an independent and unaffiliated third-party investment adviser. We generally require a minimum account size of \$500,000, subject to negotiation at our discretion.

Regular monitoring of your account(s) is included as part of our standard wealth management services, with reviews typically occurring at least quarterly. It is important that you keep us apprised of your financial situation so we can conduct more frequent reviews if necessary. In addition to wealth management and financial planning, we also separately offer income tax preparation and tax analyses with the goal of minimizing federal and state income tax liability.

What fees will I pay?

Retail investors will generally incur the following fees charged by us: wealth management fees based on a percentage of your assets under our management (which generally range from 0.50% to 1.25% per annum), financial planning fees based on an hourly rate of \$300 per hour, or financial planning fees charged at a fixed rate generally ranging between \$3,000 to \$6,000 based on the nature and complexity of services rendered (including a minimum fee of \$3,000). Clients utilizing the services of a third-party adviser are additionally charged an asset-based administrative fee that generally ranges from 0.10% to 0.25% per annum). Wealth management fees are charged quarterly in advance, and financial planning fees are paid in advance or arrears depending on the agreement between us. Retail investors will also generally incur the following fees and costs charged by third-parties: custodian fees, account maintenance fees, product expenses such as internal expense ratios, and transaction charges.

When we charge an asset-based fee, the more assets there are in your account(s), the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account(s). When we charge an hourly fee, the more time we incur in performing our services, the more you will pay in fees, and we may therefore have an incentive to be less efficient in performing services for you. When we charge a fixed fee, our fees are typically correlated to the degree of complexity involved in managing your account, and we may therefore have an incentive to add additional complexity with respect to your account(s).

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

The custodian(s) we recommend provide(s) us with various products and services that are intended to directly benefit you, us, or both of us. To the extent a custodian provides us products or services that don't directly benefit you, this creates an incentive to recommend that custodian. Third-party investment advisers, product sponsors, insurance companies, and software-based bank account facilitation companies that we recommend provide us certain benefits, such as due diligence and educational seminars along with attendance expense reimbursements, financial and marketing assistance, client event cost reimbursement, and the use of certain software. This creates an incentive to recommend the products or services of such third-parties to our clients. To the extent you purchase a security or insurance product from one of our advisors through their affiliation with a broker-dealer or insurance company, you will pay an ordinary and customary commission. To the extent you purchase real estate utilizing the real estate brokerage services of one of our advisors, you will be charged a commission related to the transaction. How do your financial professionals make money?

Our financial professionals are compensated based on the amount of client assets they service (for asset-based fees), or the time and complexity required to meet a client's needs (for hourly and fixed fees). In addition, if real estate or a security or insurance product is purchased through one of our financial professionals, such financial professionals will earn an ordinary and customary commission as a result.
