Businesses:

SBA Disaster Assistance: The Small Business Administration is offering small businesses loans for those who qualify. You must have your business information available in order to apply, such as Employer Identification Number (EIN number), gross revenue sales, and cost of goods sold.

Florida Bridge Loan: The state of Florida is offering businesses assistance with their Florida Bridge Loan. It is not a grant and it must be repaid.

Paycheck Protection Program: Paycheck Protection Program is a loan that is being offered through SBA lenders to cover payroll costs over an 8 week period after the loan is made. Contact a local SBA lender for more information. For a list of SBA lenders visit www.sba.gov.

Payroll tax credit: Families First Coronavirus Re-sponse Act (FFCRA) offers eligible employers with a payroll tax credit based on qualifying leave wages they paid for the period between April 1, 2020, and December 31, 2020. Small employers are required to pay up to 80 hours of paid sick leave for employees who are unable to work for reasons related to Covid-19.

Disaster Paid leave: Disaster leave provides employees with job protection and, when applicable, continued pay and benefits over a designated period of time when a "declaration of emergency" is issued by the President or President's designee. Disaster leave can only be granted during such a declaration of emergency, may or may not extend throughout the entire period of emergency, and may only be provided at the direction of the President/designee. Eligibility for disaster leave is solely at the discretion of the President/designee and is not an entitlement.

Individuals:

Corona virus Tax Relief (Extensions): The normal deadline of April 15th for Individual tax returns has been extended until July 15th due to the Corona virus. You are encouraged to file early, do not wait until the last minute to file your return as there can be unexpected delays in the processing of your tax return. This extension includes filing of the tax return and payment if you owe a balance on your return. Interest and penalties do apply after July 15th. After July 15th an extension is required if you need additional time to file your tax return.
