Ode to Jasper Kane

Recently, New York University Alumni voted on those alumni who worked to better our world. In a timely nod to the past, Jasper Kane, a famed biochemist was on the list. Penicillin was accidentally discovered in 1928 in the United Kingdom by Alexander Fleming while he was experimenting with the influenza virus. The discovery led to the world's first antibiotic, or bacteria killer. But the use of penicillin was limited due to it being very expensive to produce. That is, until Jasper Kane, Charles Pfizer & Company's director of research as part of the World War II effort, created a revolutionary method in 1942 for producing penicillin on an industrial scale. Because of this, the first patient treated in the U.S. was only in 1942.

The process called deep tank fermentation was a game changer for the Allied powers in World War II, a period when hundreds of soldiers died daily from infected wounds. Kane's discovery led to the bulk production of lifesaving antibiotics. According to military records, there were only 400 million units of penicillin available during the first five months of 1943. By the end of World War II, U.S. companies were making 650 billion units per month. By 1944, Pfizer was the leading producer of penicillin by fermentation, supplying 90% of the penicillin that helped treat over 150,000 soldiers wounded on D-Day. Graying Of Europe Affects COVID-19 Death Rate

In our files, we found a 20 year old article from USA Today dated 12/26/00 titled Graying of Europe affects Economies. In it was stated that more people died in Italy than were born and the country was accorded the distinction of having the oldest population in the world. The article went on to say that the average age was 45 and 17% (vs. US 13%) were over 65. Further, it said babies were scarce in Europe and the population is on the verge of decline in many countries. This had important implications for economies and religious upheavals.

Seven years ago, we had the opportunity to travel throughout Italy for two weeks and we noticed a distinct lack of babies, children and baby carriages and strollers and a surprising preponderance of African and what appeared to be Muslim immigrants.

The Wall Street Journal reported on November 23, 2020 that in Europe people over 60 make up more than 90% of the COVID-19 fatalities since the start of August, based upon an analysis of 78,000 deaths. Note that the 27 countries of the European Union and the United Kingdom reported 106,281 deaths from August 1 through November 19. Of those deaths, 67% were over 80 years of age.

A related article noted that Europe has less ability to treat COVID-19 patients since most countries, except Germany, have only 20% of the Intensive Care Unit beds percentage wise of the population as compared with the United States. The reason for the lower percentage-wise availability of beds in Europe is because their health systems are government run and due to budgetary restrictions, they have not been created; the bureaucratic theory being if there wasn't a need for the ICU beds up til now, why plan for a future need.

Although no exact comparison is available to compare the U.S. death rate vs. the European Union by age, according to the John Hopkins Corona Resource Center's Mortality Analysis as calculated through November 23, 2020 at 3AM EST, the observed case-fatality ratio of deaths per 100,000 population in USA is 2.1% vs. 3.5% for Italy. 3.6% for the United Kingdom 2.7% for Spain and 2.2% for France.

In conclusion, it appears that the average age of the population has a major effect on the COVID-19 fatality rate.
