consensus earnings results, only to come roaring back the following day. Stocks suffered another broad retreat on Friday, sending the major

indices to their worst weekly performance since October.^{4,5}

Earnings continued to surprise to the upside, with 81% of companies in the S&P 500 that reported results by last Thursday morning exceeding analysts' expectations.6

Shorts Come Into Focus The ability of social media to stoke passions and provide a catalyst to herd behavior made itself evident on Wall Street last week. A chat forum became the central hub for motivating individual investors to

trade certain stocks with large short positions. This unexpected buying activity roiled markets and fueled a sharp rise in their stock prices. The sudden surge higher forced some fund managers to buy stocks in these companies at higher prices, resulting in substantial losses for the firms.
