

### **CLIENT PRIVACY POLICY**

Intelligent Investment Management, LLP maintains a commitment to confidentiality and privacy of client information. We are committed and bound to do so as a matter of trust between our clients and Intelligent Investment Management, LLP. Please read our privacy policy below to learn more about how we treat and safeguard the personally identifiable financial information of our clients and former clients.

When we use the words "you" and "your" in this policy, we mean current or former clients who have or have had a continuing client relationship with Intelligent Investment Management, LLP. "Nonpublic personal information" means information about you that we collect in connection with providing you our services. Nonpublic personal information does not include information that is available from public sources such as county records and telephone directories.

#### **How We Gather Information**

We collect nonpublic personal information about you to enable us to provide you with our services. We collect information furnished by you on account applications or other forms you submit. This information is collected from you through written correspondence, by telephone and through information you provide us or direct us to obtain for financial planning purposes. Information is also collected through electronic means such as e-mail as well as in the course of your personal consultations, interviews and contacts with our employees. We may collect nonpublic personal information from other companies or professionals you may retain such as fiduciaries, accountants and other investment advisors. We collect such information so that we can effectively provide the services you require. The information we collect may include your name, address, date of birth, identification photos, driver's license number, telephone and facsimile numbers, email addresses, Social Security number or tax identification number, beneficiary information, banking and tax return information and investment objectives. Once you have opened an account, we manage your account by collecting and maintaining personal information about your transactions including balances, positions and account history.

# **Restrictions on Disclosure of Nonpublic Personal Information**

We do not disclose any nonpublic personal information about our clients or former clients to anyone, except as permitted by law. Unless a client has specifically authorized us to do so, we do not disclose your personal information to others except in the following limited circumstances:

- We disclose personal information to non-affiliated co-advisors, brokers and other agents, including TD Ameritrade Institutional and other custodians. This helps us provide advisory services, market our services, process your transactions and service your accounts. We may also provide your information to vendors providing data processing, computer software maintenance and development, customer relationship management (CRM) systems, financial record and communication archive storage systems, compliance and legal consulting, and other general business consulting services. These vendors are required to comply with Federal and State requirements for secure encryption during transport and storage of data and have a nondisclosure agreement agreeing to maintain the confidentiality of all nonpublic personal information.
- We may also disclose personal information if we believe in good faith that such disclosure is required to comply with applicable laws, such as cooperating with regulators or to resolve consumer disputes.

### **Our Security Practices**

We will take steps to safeguard your nonpublic personal information. We restrict access to nonpublic personal information of clients and former clients to those employees who need to know that information in the course of their responsibilities with the Firm. We maintain physical, electronic and procedural safeguards to guard your information. We do utilize vendors who provide services in "the cloud" and these vendors do comply with Federal and State requirements for secure encryption during transport and storage of data. However, no system is perfectly secure or reliable, the internet is an inherently insecure medium, and the reliability of hosting services, internet intermediaries, your internet service provider, and other service providers cannot be assured. As a client of Intelligent Investment Management, LLP you accept these risks and the responsibility that technology does not provide perfect security or reliability.
