UCWM sponsors and manages two wrap fee programs, the Prime Advisory Portfolio and Prime Intelligent Portfolio Programs, where the client pays one fee for both investment advisory services and the transaction costs and UCWM pays the custodial broker/dealer a portion of the fees to cover the transaction costs. UCWM will place a client in wrap fee account when the account is an actively traded account helping to defray the transaction costs.

A Wrap Fee Program is an investment advisory program in which Clients pay one fee for both investment advisory services and the transaction costs in the account(s). The fee is bundled with UCWM's costs for executing transactions in the account(s). This results in a higher advisory fee to the Client. UCWM does not charge Clients higher advisory fees based on the trading activity, but Clients should be aware that Universal Capital Wealth Management has an incentive to limit the trading activities in the account(s) because UCWM is charged for executed trades. By participating in a wrap fee program, Clients will end up paying more or less than they would through a non-wrap fee program where a lower advisory fee is charged, but trade execution costs are passed directly through to the Client by the executing broker. For more passively traded accounts, a wrap fee account would normally not be advantageous to the client.

The Program Fee is not based directly upon the actual transaction or execution costs for the transactions within the account(s). Depending on the underlying investments in the Program and how much trading activity occurs, Clients will pay more or less than if they chose another advisory program that does not have a wrap fee, or if Clients chose to pay separately for all of the transaction costs (e.g., pay the advisory fee plus all transaction charges). Although UCWM believes its fees are competitive, Clients are hereby advised that lower fees for comparable services are available from other sources.

UCWM offers its Prime Intelligent Portfolio Program through Schwab Intelligent Portfolios<sup>®</sup>, sponsored by Charles Schwab & Co., Inc. ("Schwab"). Schwab provides administration and related services for the Program. Charles Schwab Investment Advisory, Inc. ("CSIA"), an affiliate of Schwab, provides portfolio management services. UCWM is independent of and not owned by, affiliated with, sponsored by or supervised by Schwab Intelligent Portfolios<sup>®</sup>, CSIA, or Schwab. The CSIA platform is described in detail in the Schwab Intelligent Portfolios<sup>®</sup> Disclosure Brochure (the "Disclosure Brochure"), which is delivered to clients by CSIA during the online enrollment process.
