

### Investment Strategy: Strategic and Passive

This PFG Strategy utilizes underlying Fidelity® Index-Focused portfolios. The Strategy seeks total return (capital appreciation and income), while seeking to provide investors primarily with potential lower cost exposure to global equities. The Strategy is diversified across market capitalization and regions, with approximately 70% in domestic equities and 30% in foreign equities. Because of the passive nature and lower cost of the underlying positions, this Strategy works very well as a core option for the PFG Portfolio Management team and therefore it can be found in several of the PFG Strategy PLUS™ Model Portfolios such as Focus PLUS™, Index PLUS™, and Multi PLUS™.



- The Fund is a new mutual fund and has a limited history of operations for investors to evaluate.
