Ullmann Wealth Partners Group, LLC ("we", "our" or "us") is registered with the Securities Exchange Commission ("SEC") as an investment adviser. Our services and compensation structure differs from that of a registered broker-dealer. Free and simple tools are available to research firms and financial professionals at www.investor.gov/CRS. The site also provides educational materials about broker-dealers, investment advisers and investing. What investment services and advice can you provide me?

We provide Wealth Management Services for individuals and families and their trusts and estates (our "retail investors"). Our Wealth Management Services consists of Investment Management, Advanced Planning and Relationship Management Services. In select cases, we may also provide Advance Planning, Relationship Management, and Divorce Advisory Services on a stand-alone basis. Our Divorce Advisory Services are designed to protect client's financial assets before, during, and after a divorce. Each of these services are described in more detail in our Form ADV Part 2A

Our Wealth Management Services allow you to pay one fee for Investment Management, Advanced Planning Advice and Relationship Management Services, which includes the brokerage and custody costs incurred by your account.

As part of our Investment Management Services, we provide ongoing management of your assets based on your investment objective(s), risk tolerance, life values, goals, investment time horizon, and overall financial situation. We construct a portfolio of investments for you. We do not limit the scope of the universe of securities that we use in managing client accounts, and we may use mutual funds, exchange traded funds ("ETFs"), equities, options, debt securities, and other investments. We design each portfolio to meet your individual needs, stated goals and objectives.

We monitor clients' portfolios periodically and make changes as we determine necessary. We typically manage portfolios on a discretionary basis, which means we have the authority to buy and sell investments in your account without speaking to you prior to doing so. You can place reasonable restrictions on the securities that we buy by notifying us, in writing.

We don't typically have a minimum asset level for our retail investors although we do have a minimum annual fee of \$2,500 for clients receiving our Full Scope Wealth Management services.

What fees will I pay?

Our Full Scope Wealth Management Services fee is based on a percentage of your assets under our management. Clients also are responsible for all fees and expenses imposed by third parties for trading and holding their assets, including commissions, mark-ups, markdowns and spreads to trade securities, fees for custody, administrative services and consolidated reporting and any other fees and taxes imposed by brokers, custodians and securities exchanges.

Our Stand Alone Advanced Planning and Relationship Management and Divorce Advisory Services fees are based on your liquid net worth.

We generally deduct our fee from one or more of your investment accounts on a quarterly basis, in advance. For Wealth Management Services, the more assets you entrust us to manage, the more you may pay us for our services. Therefore, we have an incentive to encourage you to increase the amount of assets that you entrust to us.

Your account will be held with a qualified custodian. Your assets may be invested in mutual funds and ETFs. You will bear

your pro rata share of the investment management fees and other fees of the funds, which are in addition to the fees you pay us. These fees and expenses are described in each fund's prospectus and potentially include a management fee, distributionfee (i.e., rule 12b-1 fee), and other fund expenses. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time although we generally seek to reduce internal investment costs. Please make sure you understand what fees and costs you are paying.

Help me understand how these fees and costs might affect my investments. If I give you \$1,000,000 to invest, how muchwill go to fees and costs, and how much will be invested for me?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means:

- * We may recommend a particular custodian from whom we receive support services. This presents a conflict of interest, because our receipt of their support make us more inclined to continue using and recommending them.
- * We may recommend rollovers out of employer-sponsored retirement plans and into Individual Retirement Accounts that we manage for an asset-based fee. If we don't currently manage your account held with your employer's plan, this will increase our compensation.

How might your conflicts of interest affect me, and how will you address them?

How do your financial professionals make money?

Our financial professionals are all paid based on salary. Certain of our financial professionals receive compensation that is based on our overall revenue. Other financial professionals are eligible to receive discretionary bonuses that are based on various factors. Your financial adviser may also be compensated by our indirect parent company, Focus Financial Partners, LLC (or one of its affiliates), based on our earnings. This gives your financial adviser an incentive to encourage you to increase the size of your investment account and to maintain your investment account with us, rather than transition it to another adviser.
