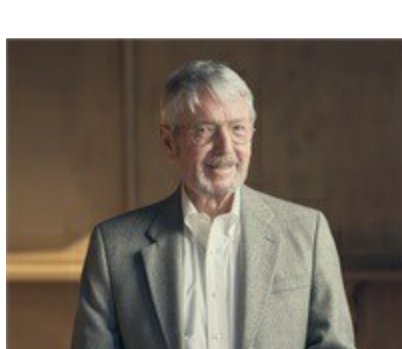
February indeed has been a month to behold.

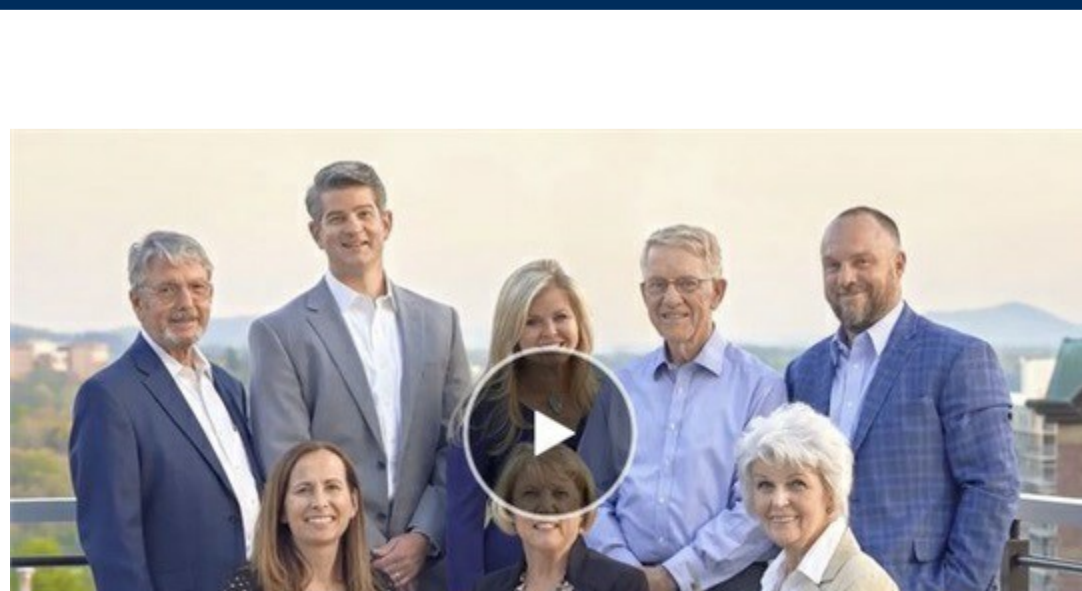

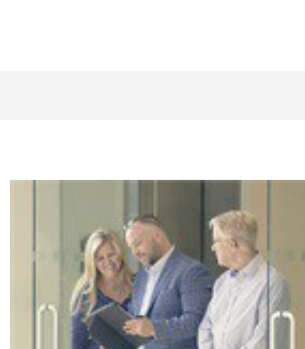
