**Updated CDC Mask Guidelines**  
May 20, 2021

Recently the Centers for Disease Control (CDC) released updated masking guidance that fully vaccinated individuals no longer need to wear a mask. We are encouraged to see this progress as our firm works to normalize our client interaction process.

Mersberger Financial Group has been following the guidance of the CDC throughout the COVID-19 pandemic and we will continue to adapt our practices as new or updated information is released. To remain consistent with CDC guidance, clients and employees that have been fully vaccinated will no longer need to wear masks inside of our office or in client meetings.
