Information We May Collect From You

Our web site's insurance quote and information request forms require users to provide us with the following information:

1. Contact information: your name(s); mailing address; email address(es); and telephone numbers.
2. Property addresses; driver license numbers; dates of birth; and financial and health information.
3. Current/prior insurance coverage, profile data, and/or any other information necessary to prepare a quote.

Contact information from the insurance quote forms is used to contact customers when necessary. This data is necessary for the processing of, and future identification of, insurance quotes and confirmation of mailing addresses, and is used solely for those purposes.

Who Receives Your Information

1. Information will be provided to one or more insurance companies and, in certain instances, the Federal Health Insurance Marketplace, for quoting purposes.
2. If you purchase an insurance policy from one of those insurers or through the Federal Health Insurance Marketplace, the contact information you provided will be used to establish you as a policyholder.

Albritton Insurance Services, LLC, never gives or sells this information to third parties for any purpose. Demographic, financial and health information is also collected at our site, depending on your insurance interests and needs. This data is also necessary for processing insurance quotes, purchasing insurance, and is used solely for that purpose. This information is never given or sold to third parties for any purpose. Albritton Insurance Services, LLC, will not sell, rent, or lease your personal information.

Personal Information

The personal information you provide may be transmitted electronically to an insurance company or the Federal Health Insurance Marketplace, and a record stored at our office on our secure computer system. Our employees are required to sign a Confidentiality and Nondisclosure Agreement. Each employee is aware of the sensitivity of your personal information and maintains the privacy of each client.
