When and Where Can I get my COVID-19 Vaccine? More Resources Speed Distribution

The first two approved COVID-19 vaccines, Pfizer and Moderna are being distributed now and others are expected to be approved soon. While the COVID-19 vaccine roll out started slowly, we are finally seeing a glimmer of light at the end of the tunnel that will eventually allow us to return to some sense of normalcy. Over the last few weeks, we have seen an increase in COVID-19 vaccination sites and availability here in the San Francisco Bay Area. Moscone Center in San Francisco just opened as a mass COVID-19 vaccine site last week. Levi's Stadium in Santa Clara opened this week too. They each hope to respectively ramp up to be able to vaccinate 10,000 and 15,000 people a day.^{1,2} The Oakland Coliseum is scheduled to open on February 16th and is said to be able to administer 6,000 doses of the vaccine per day.³ In addition, CVS Pharmacies are scheduled to begin delivering COVID-19 vaccines on Friday, February 12th. (Check their website at CVS.com to learn if they have started offering COVID-19 vaccinations near you.)


California is currently in the Phase 1A and 1B (Tier 1) stage of the rollout. Phase 1A eligible individuals includes healthcare workers and long-term care staff and residents. Phase 1B, (Tier 1) which recently started includes persons 65 years of age or older and individuals working in education and childcare, emergency services, and food and agriculture. In Phase 1B (Tier 1) most vaccinations are being given to persons age 65 or older. Individuals working in education and childcare, emergency service, and food and agriculture, depending upon county may find that the vaccine supply is not yet available.

It is one thing to qualify as an eligible individual; actually getting the vaccine is another. We would suggest you first contact your affiliated medical plan, medical group or hospital to schedule an appointment. For those of you who are eligible individuals in Phase 1A and 1B as noted above who are having difficulty finding a location to schedule a vaccine appointment you may want to visit the website vaccinateCa.com. VaccinateCA.com is a community driven website that provides information regarding locations that have reported vaccine availability in your surrounding area.

Who will be vaccinated next? The chart above is constantly changing.⁴ Eligible individuals in Phase 1B (Tier 2) and after are yet to be determined. Phase 1B (Tier 2) and 1C that previously focused on individuals in certain occupations are now focusing more on an age-based distribution. Details regarding exact eligibility for future phases are still being discussed.

We know that everyone who wants to be vaccinated will eventually be able to receive their inoculations. Staying patient until we receive our vaccine doses is challenging since we all want to get to herd immunity as soon as it is possible.

In the meantime, we continue to follow the recommended safety protocols in our office. We limit the team members in our office daily (many of us are primarily now working remotely) and we have installed protective screens to enhance employee safety.
