## **Temporary Relocation**


We are excited to announce that our entire downtown office will be undergoing a complete renovation starting Friday, March 10th!


#### **Frequently Asked Questions:**

- Where is it located?
  - 318 Main St. on the 3rd floor. Location is across from the old Hilliard Lyons building.
- Where can I park?
  - There are a couple of options for you, all of which are listed in detail on the next page.
- Will this affect my meeting with my advisor?
  - It will not, the new location will have meeting rooms allowing you to meet with your advisor as you always have.
- How long will you be there?
  - We are told this will take approximately 6
    months. However, this is not a guaranteed time
    frame and we will keep you updated as we know
    more.
- How will we contact you?
  - All of our business phone numbers will remain the same. We have mail forwarding set up to our PO box, so you do not need to worry about mailing to a new address.
- What if I need to drop things off or pick something up from you?
  - You will still be able to drop off/pick up any paperwork as you always have. Please call us ahead of time so we know when to expect you.
- What about my other concerns?

## **Temporary Relocation Parking**

#### Parking Options:

- Street parking along Main Street and all side streets is open but subject to availability.
- Please note that most Main Street parking has a 2 hour maximum and this is highly regulated.
- Sycamore Street Parking Garage located on the corner of 5th & Sycamore will be available. Entry to the garage is on 5th Street. Bring us your parking ticket so that we can validate for you.
- 3rd Street Parking Garage located on the corner of 3rd Street & Locust Street will be available. Entry to the garage is on Locust Street. Bring us your parking ticket so that we can validate for you.
- Other parking garages are available, however, we will not be able to validate parking for any garage not listed above.


#### **Important Changes**


