

Investment Strategy: Tactical and Passive

The PFG BNY Mellon Diversifier Strategy R is a dynamic, diversified multi-asset, fund of funds portfolio. The Fund seeks to limit the maximum range of total returns to a gain or loss of less than 15%, over a forward-looking rolling 12-month period. The strategy is intended to provide mild expected drawdown in times of market stress, within the larger context of a balanced or risk-averse portfolio. This is achieved by attempting to minimize drawdown while delivering some modest capital appreciation and staying within the RiskPro Tolerance (a proprietary, volatility-based measure) range of 0 to 15. The strategy is intended to provide an active sleeve of risk mitigation that is more economically robust, diversified, and adaptive -- when compared against a conventional bond portfolio -- through the use of inflation-hedging equities and diversifying alternatives strategies in addition to multiple fixed income strategies. This particular portfolio construction is particularly desirable in a rising rate environment (when duration-sensitive assets typically underperform) or when the outlook for fixed income performance diverges across global regions, credit spectrum, or term structure.


