## Item 1: Introduction

WEALTH ADVISORS NW is an investment adviser offering advisory accounts and services. Brokerage and investment advisory services and fees differ, and it is important that you understand the differences. This document gives you a summary of the types of services and fees we offer. ## Item 2: Relationships and Services

Questions to ask us: Given my financial situation, should I choose an investment advisory service? Why or why not? How will you choose investments to recommend to me? What is your relevant experience, including your licenses, education and other qualifications? What do these qualifications mean?

What investment services and advice can you provide me? Our firm primarily offers the following investment advisory services to retail clients: portfolio management (we review your portfolio, investment strategy, and investments); financial planning (we assess your financial situation and provide advice to meet your goals). As part of our standard services, we typically monitor client accounts on a 3-month basis. Our firm has discretionary management without any material limitations. We limit the types of investments that are recommended since not every type of investment vehicle is needed to create an appropriate portfolio, but do not limit these investments to proprietary products.Our firm does not have a minimum account size. Please also see our Form ADV Part 2A ("Brochure"), specifically Items $4 \& 7$.

## Item 3: Fees, Costs, Conflicts, and Standard of Conduct

Questions to ask us: Help me understand how these fees and costs might affect my investments. If I give you $\$ 10,000$ to invest, how much will go to fees and costs, and how much will be invested for me? How might your conflicts of interest affect me, and how will you address them?

What fees will I pay? Our fees vary depending on the services you receive. Additionally, the amount of assets in your account affects our advisory fee; the more assets you have in your advisory account, the more you will pay us and thus we have an incentive to increase those assets in order to increase our fee. For hourly fee arrangements, each additional hour (or portion thereof) we spend working for you would increase the advisory fee. Our fixed fee arrangements are based on the amount of work we expect to perform for you, so material changes in that amount of work will affect the advisory fee we quote you. Investment management fees are charged in 3 month cycles, starting the month an Investment Advisory Agreement is signed, in arrears using the average daily balance over the period. For portfolio's under $\$ 250,000$ we charge $\$ 2,400$ for the first year and includes the financial plan and portfolio management for assets under management. Clients have the choice to pay the $\$ 2,400$ monthly over the course of the year at $\$ 200$ per month. After the first year accounts with balances will be billed at the agreed upon AUM fee. Portfolios over $\$ 250,000$ include financial planning at no additional charge. You pay our fees even if you do not have any transactions and the advisory fee paid to us generally does not vary based on the type of investments selected. How do your financial professionals make money? Primarily, we and our financial professionals receive cash compensation from the advisory services we provide to you because of the advisory fees we receive from you.
