



RECORD RETENTION GUIDELINES

Tax returns can generally be audited for up to three years after filing and up to six years if the IRS suspects underreported income. It is wise to keep tax records at least four years after a return is filed. Requirements for records kept electronically are the same as for paper records. Generally, follow these recommended periods for various documents:
