BE PREPARED FOR THE UNEXPECTED.


No matter how well you plan, unexpected expenses will likely come up. Aim to build a buffer into your budget so you can cover these costs without breaking the bank.

OF YOUR TAKE-HOME PAY
ON ESSENTIAL NEEDS, **30%**
ON WANTS AND
SAVE AT LEAST **20%**.

How much can I put into my 401(k)?

The amount you can contribute to your retirement plan is based on the type of plan and how old you are. Generally speaking, in 2023, you can save in a 401(k) up to \$22,500, and those over 50 years old can sock away an additional \$7,500. The best way to get out of debt is to make sure the payments you make each month are more than what you spend on credit cards (don't forget interest and fees) or loans.
