Overview

LPL Research is making share class exchanges within the Strategic Asset Management (SAM) portfolios.

Effective November 21, 2016, LPL no longer offers Class A shares with 12b-1 fees on the Strategic Asset Management (SAM) platform for purchase or exchange. In addition, SAM offers a single share class per fund. While legacy share classes are no longer available for purchase or exchange, your clients may continue to hold these existing positions in their portfolios. Given the focus in the industry on reducing potential conflicts of interest, and as part of our efforts to deliver more clarity and standardized pricing, LPL simplified the choice set in our SAM platform. This change not only drives lower overall fees for your clients, but also aligns with both client and advisor interests in regard to providing greater fee transparency. This results in a more competitive platform that better reflects marketplace trends.
