

<b>FACTS</b>	<b>WHAT DOES CORSAIR CAPITAL MANAGEMENT, L.P. DO WITH YOUR PERSONAL INFORMATION?</b>	
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• Social Security number</li> <li>• Account balances</li> <li>• Transaction history</li> <li>• Name, address and any other additional information disclosed to us in a Subscription Agreement</li> <li>• Income</li> <li>• Investment experience</li> <li>• Wire Transfer Instructions</li> </ul> <p>When you are no longer our customer, we continue to share your information as described in this notice.</p>	
<b>How?</b>	All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Corsair Capital Management, L.P. chooses to share; and whether you can limit this sharing.

What we do	
<b>How does Corsair Capital Management, L.P. protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does Corsair Capital Management, L.P. collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>▪ Open an account</li> <li>▪ Make a wire transfer</li> <li>▪ Make deposits or withdrawals from your account</li> <li>▪ Fill out and return a subscription agreement</li> <li>▪ Give us your income information</li> <li>▪ Give us your contact information</li> </ul>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Our affiliates include financial companies such as Corsair Capital Advisors, L.L.C., Corsair Select Advisors, L.L.C., and Corsair Operations Management, L.P.</i></li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Corsair Capital Management, L.P. does not share with nonaffiliates so that they can market to you.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>▪ <i>Corsair Capital Management, L.P. does not jointly market.</i></li> </ul>
Other important information	
<p>* As described above, we may disclose information we collect from you in connection with our everyday business purposes. Examples of our everyday business purposes include, without limitation: (a) in connection with the administration and execution of the services we provide for you and your account, such as in preparing tax forms and verifying securities law compliance; (b) as required and/or permitted by law, regulation and/or legal process; and (c) as required and/or requested by a government agency, self-regulatory organization or financial regulatory authority, including, without limitation, in connection with our affiliated investment funds' making or maintaining an investment.</p> <p>** If you were introduced to us by a nonaffiliate who earns a commission for such introduction, such nonaffiliate shall be required to disclose this relationship to you. We will provide information concerning your investment to such nonaffiliate. Any restriction on our ability to provide such information to such nonaffiliate shall require the consent of Corsair Capital Management, L.P. and such nonaffiliate.</p>
