### Mutual Funds

We have relationships with more than 500 **supporting fund families** providing access to thousands of mutual funds, including institutional shares for PPS accounts.

Four **nonsupporting mutual funds** do not support intermediary distributions, resulting in higher transaction fees. They are CGM, Dimensional Fund Advisors (DFA), Dodge & Cox, and Vanguard.
