Those with the CLU® designation have demonstrated competency in the areas of insurance needs for individuals and business owners and have completed 5 required and 3 elective courses. Courses cover fundamentals of insurance planning, life insurance law, fundamentals of estate planning and planning for retirement needs. In addition to successful completion of an exam in each course of study, candidates are required to have a minimum of three (3) years of business experience.
