## Ginsburg Financial Advisors, Inc. Reopening Procedures

In California, on June 15, 2021, Governor Gavin Newsom lifted many of the executive orders in accordance with CDC guidelines to safely reopen the economy. In doing so, this helped many businesses by lifting capacity restrictions, distancing and mask requirements.

Ginsburg Financial Advisors, Inc. (GFA) has slowly reopened our office for in-person client visits. Our staff has been fully vaccinated and has returned to our office.

Our main concern is to ensure the safety and well-being of our clients, staff, and their families. Please find below GFA's "Reopening Procedures" for in-person visits which have been slightly modified from CDC guidelines.

- The front door of GFA will remain locked for now with our Administrators granting entry to clients and vendors as needed.
- GFA wants staff and clients to feel that they are returning to a protected environment. We will continue to offer support to our clients by phone, email, and zoom.
- We have started scheduling in-person meetings or client visits (check deposit drop-offs, etc.) at the office.
- Any client that wishes to visit the office will be asked if they are fully vaccinated. If you are fully vaccinated, we can proceed to schedule an in-person meeting or visit.
- If you are not fully vaccinated, we can offer you another option that will ensure the safety of all participants. We will not meet with anyone who is not fully vaccinated.
- The fully vaccinated client can choose to wear a mask or not wear a mask.
- We ask that if you have traveled outside of the United States to please wait 10 days before you schedule an appointment to visit our office.
