Businesses:

Paycheck Protection Program: If you applied for the Paycheck Protection Program, December 31, 2020 is the cutoff date for eligible expenses for this program. Eligible expenses for this program include rent, utilities, mortgage interest and payroll. **Forgiveness for the Paycheck Protection Program is not automatic, you must apply for this or you will have to pay back what you received with interest.**

Increase in Minimum Wage: Florida's minimum wage will be increasing from \$8.56 to \$8.65 for hourly employees and from \$5.54 to \$5.63 for tipped employees beginning on January 1, 2021. Beginning on September 30, 2021 Florida's minimum wage will be \$10.00 for hourly employees and \$6.98 for tipped employees.

Physical Inventory: Schedule your physical inventory for your business before the end of the year. Make inventory adjustments to match your actual inventory counts and run any necessary reports required for the processing of the tax return. The end of the year inventory should reconcile with what's reported on the accounting records and the income tax return.

Individuals:

Required Minimum Distribution (RMD): **Required Minimum Distribution (RMD) have been waived for tax year 2020 as relief due to the coronavirus. If you are seventy and a half (70 ½) years old or older, you can still take your RMD if needed.**

Year-end tax planning: Take advantage of the last month of the year and schedule your year-end tax planning appointment now before next tax season begins to help minimize your taxes.
