

Website Visitors

Like most website operators, Akin & Akin Insurance collects non-personally identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Akin & Akin Insurance's purpose in collecting non-personally identifying information is to better understand how Akin & Akin Insurance's visitors use its website. From time to time, Akin & Akin Insurance may release non-personally identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Akin & Akin Insurance also collects potentially personally identifying information like Internet Protocol (IP) addresses. Akin & Akin Insurance does not use such information to identify its visitors, however, and does not disclose such information, other than under the same circumstances that it uses and discloses personally-identifying information, as described below.

Gathering of Personally-Identifying Information

Certain visitors to Akin & Akin Insurance's websites choose to interact with Akin & Akin Insurance in ways that require Akin & Akin Insurance to gather personally-identifying information. The amount and type of information that Akin & Akin Insurance gathers depends on the nature of the interaction. For example, we ask visitors who sign up for an account at this website to provide a username and email address. Those who engage in transactions with Akin & Akin Insurance are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Akin & Akin Insurance collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Akin & Akin Insurance. Akin & Akin Insurance does not disclose personally identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Use of Personal Data

Akin & Akin Insurance may collect aggregated statistics about the behavior of visitors to its websites. For instance, Akin & Akin Insurance may monitor the most popular website account on this site. Akin & Akin Insurance may display this information publicly or provide it to others. Akin & Akin Insurance does not disclose personally identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Akin & Akin Insurance discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Akin & Akin Insurance's behalf or to provide services available at Akin & Akin Insurance's websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Akin & Akin Insurance's websites, you consent to the transfer of such information to them. Akin & Akin Insurance will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Akin & Akin Insurance discloses potentially personally-identifying and personally-identifying information only when

required to do so by law, or when Akin & Akin Insurance believes in good faith that disclosure is reasonably necessary to protect the property or rights of Akin & Akin Insurance, third parties or the public at large. If you are a registered user of an Akin & Akin Insurance website and have supplied your email address, Akin & Akin Insurance may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Akin & Akin Insurance and our products. We expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Akin & Akin Insurance takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Akin & Akin Insurance uses cookies to help Akin & Akin Insurance identify and track visitors, their usage of Akin & Akin Insurance website, and their website access preferences. Akin & Akin Insurance visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Akin & Akin Insurance's websites, with the drawback that certain features of Akin & Akin Insurance's websites may not function properly without the aid of cookies.
